TRAVEL REQUIREMENTS

The PAP's are required to make two trips to the Republic of Bulgaria. The first trip is required to visit with the child for at least for 5 days after receipt of a referral and the second trip is the pick-up trip after the adoption is completed.

1. First trip – 7 days stay: Hotel – 500-1500 BGN; transport expenses – 400-800 BGN; visa fee for 1 child – 325 USD charged by the American Embassy in Sofia
2. Second trip 11 days stay: Hotel: 1200-2000 BGN; transport expenses – 400-800 BGN
